Remarks:

- 1. The calculation of registration dates, class commencement (start) dates, and semester durations are based on the official calendar announced by each school; if a school has not specified a registration date, the registration payment deadline shall be considered the registration date.
- 2. For students applying for leave of absence or withdrawing voluntarily, the date of official submission of the leave of absence or withdrawal application to the school's designated unit by the student (or parent) shall be the calculation reference date; for those required to withdraw by order, the withdrawal date shall be based on the date of receipt of the school's withdrawal notice. However, for students who continue to attend classes on campus due to appeals or complaints against the withdrawal decision, the actual departure date shall be used as the calculation reference date.
- 3. Students applying for leave of absence or withdrawal shall complete the departure procedures within the designated period specified by the school; if there is any delay in the relevant procedures attributable to the student, the actual departure date shall be used as the calculation reference date.
- 4. Schools are not allowed to collect any fees in advance before the start date of the semester as specified in the school calendar.

* In addition to the refund criteria table mentioned above, the supplementary fees of our school are as follows:

- 1. For first-year freshmen and transfer students with a waiting list system who apply for withdrawal before the school's admission waiting list deadline (inclusive) (without retaining student status), after deducting administrative fees from the tuition and miscellaneous fees, a full refund will be granted. The administrative fees shall not exceed 5% of the total amount of tuition and miscellaneous fees, credit fees, credit tuition and miscellaneous fees, and the base amount of tuition and miscellaneous fees that the student should pay. For students applying for leave of absence (retaining student status) and those applying for leave or withdrawal after the school's admission waiting list deadline, refunds shall be processed according to the refund ratio specified in the Regulations for the Collection of Tuition and Miscellaneous Fees at Junior Colleges and Higher Education Institutions.
- 2. Other fees of our school, such as accommodation fees, accommodation electricity charges, computer and internet communication usage fees, and language practice fees, shall also be refunded proportionally according to the withdrawal or leave of absence time as indicated in the table above.
